Minutes of Prior Meeting: Minutes of the March 17, 2022, meeting was presented. It was requested they be reviewed, and any changes or corrections be indicated. John Gray made a motion to accept the minutes as submitted, and Jeff Jakobeit seconded. The motion passed by all council members 4-0.

City Attorney comment: BVRT Consent should be limited to area containing their CCN permit. Also Stated that regarding special permits, there are no limits on what the city can set for the community. City can start to establish zoning.

Administrator comments: TXDOT will be doing a traffic survey on FM1327. City will need to decide if requirements will remain 2.5 acres lots. City can start zoning areas of the city through the proper process. The solid waste disposable grant was approved, partnering with Travis County, TDS and our city held in 2023. Project- 216 has chosen to use Taylor Morris Homes builder. City of Neiderwald council meeting, spoke of possibly creating interlocal code enforcement. Gannaway donated an acre to the city, out of the flood plain with half acre in the flood plain for parking. Some vandalism was caught it was 2:00 pm in daytime so the Cameras paid off. City bought new equipment, a new mower and maintainer. Would like to see a development meeting/workshop scheduled each month, so that the city gets ready for the future development. Stated Anna was doing a good job of keeping all on track for the budget.

Mayor comments: Appreciate all the hard work everyone puts in. Reminds everyone about May Fest, car show, booths, food, kid's games. Encourages all to come out and attend. CCCFA needs volunteers to get with Sabrina President of CCCFA. The development workshops would be a good idea as it would help the city.
