B. PUBLIC COMMENT

D. EXECUTIVE SESSION

1. Discuss and consider possible action regarding Public Utility Commission Docket No. 53187, *Application of Aus-Texas Parts & Services Ltd. and Camino Real Utility Company LLC for Sale, Transfer or Merger of Certificate Rights in Caldwell and Travis Counties*, including withdrawing the City of Creedmoor's consent to such application and filing a request to intervene (private consultation with attorney—Section 551.071 of the Government Code).

The City Council will reconvene into regular open session upon the conclusion of the executive session. The City Council may take action on any item posted in executive session, as necessary.

E. ACTION ITEMS

1. Discuss and consider possible approval of Ordinance No. 220705, affirming that the City of Creedmoor is authorized to provide retail water and sewer service inside or outside its corporate boundaries, in accordance with applicable law.
