ORDINANCE 090319-A

AN ORDINANCE OF THE CITY OF CREEDMOOR, TEXAS,
PROVIDING FOR REGULATION AND RESTRICTION OF
TRUCK TRAFFIC ON CERTAIN ROADWAYS; PROVIDING
FOR PENALTIES FOR VIOLATION; PROVIDING FOR SEVERABILITY;
AND PROVIDING AN OPEN MEETINGS CLAUSE.

WHEREAS, it has been found by the Board of Aldermen of the City of Creedmoor, Texas, that regulation of truck traffic on certain roadways within the City of Creedmoor is necessary for traffic safety and the public health and safety;

NOW, BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF CREEDMOOR, TEXAS, THAT:

Section 1. The operation of commercial truck vehicles is expressly prohibited in and upon the following roadways within the City of Creedmoor, Texas for any purpose other than delivery to or origination from locations within the City of Creedmoor, Texas:

1. That portion of the City street known as 1625 from the junction of state highway FM1625 and the City street known as 1625 southward to the City limits;
2. That portion of the City street known as Wright Road from the intersection of state highway FM 1327 southward on Wright Road to the City limits.

Section 2. Any individual or entity violating any provision of this ordinance shall be deemed guilty of a misdemeanor and upon conviction thereof shall be punished by the assessment of a fine not to exceed two thousand dollars (\$2,000.00) and a separate offense shall be deemed to have been committed as to each instance of violation of this ordinance. Upon direction of the Board of Aldermen the attorney for the City shall be entitled to seek injunctive relief as well as other penalties to enforce this ordinance.

Section 3. The Board of Aldermen of the City of Creedmoor, Texas have found that an emergency exists which requires that this ordinance become effective on the date of passage to protect the health, safety and general welfare of the City and its citizens.

Section 4. It is hereby declared to be the intention of the City of Creedmoor Board of Aldermen that all sentences, phrases, sections or provisions of this ordinance are severable and if any should be declared invalid by any court of competent jurisdiction such invalidity shall not affect the remaining portions of this ordinance which may reasonably be given effect after severance of the invalid portions of this ordinance, and to that end every provision of this ordinance is declared to be severable.

Section 5. It is hereby found and determined that the meeting at which this ordinance was passed was open to the public and that public notice of the time, place, and purpose of said meeting was given as required by the Open Meetings Act, Chapter 551, Texas Government Code.




